Social Security Changes 2011

The **Social Security (FICA) Tax Rate** has been reduced from **6.2%** of gross pay down to **4.2%**. This applies to 2011 only. Since our pay checks were issued on January 1st, this applies to our December warrant and will expire with our November paycheck which we will receive in December. After that the Rate goes back to 6.2%. This does not apply to the **Medicare Rate** which remains at **1.45%** of gross pay.

The FICA tax applies to income earned up to **\$106,800**. Anything above that is not taxed by Social Security. The Medicare tax does not have a limit.

Membership Numbers

As of December 15th, 2010 the PECG San Diego Section has **680** members out of **793** represented employees. This gives us a membership rate of 86% and puts our Section in third place (in terms of membership percentage) out of the 17 PECG Sections. This includes all state employees working as Engineer, Surveyors, Architects, Engineering Geologist, Landscape Architects and other related categories.
