Senate Bill 851 – Short on Solutions and Substance

On February 18th, State Senator Joel Anderson of the 36th District (R–El Cajon) introduced Senate Bill (SB) 851. The current wording of the bill lacks details and simply states that it would enact "the need for highway construction" as part of a long term budget solution.

Since then, the Senator (through a press conference and an Op-Ed piece) has provided more information. He has criticized Caltrans for its "wasteful practices" and "excessive" salaries.

His remedy is to eliminate Caltrans by using local agencies to administer the work which would be done by consultants that will somehow have less than "excessive" salaries. It should be pointed out that the average pay for a Caltrans Transportation Civil Engineer is \$113,000 compared to an

average of \$226,000 for a comparable private sector engineer. So, this proposal would actually cost the State more than having Caltrans perform the work in question.

The Senator went on to specifically criticize Caltran's participation at the 2009 Annual AASHTO (The American Association of State Highway and Transportation Officials) meeting in Palm Desert. These annual meetings are attended by representatives from most, if not all, of the other states as well as the federal government and it would have been highly suspect if Caltrans had not participated as this particular meeting was being held in our home state.

Considering the 2010 AASHTO Annual Meeting was held in Mississippi and the 2011 meeting will be held in Detroit, Michigan, the Senator surprisingly chose to criticize Caltrans participation in the one AASHTO annual meeting that actually brought tens of thousands of dollars of

much needed revenue into the State of California.

The Senator also went on to criticize the construction of the new Caltrans District Office in Old Town San Diego.

It should be noted that the State
Department of General Services, and not
Caltrans, deemed that the new complex
was necessary in light of the fact that the
old Caltrans District Office building on Juan
Street was and still is not compliant with
the latest Building Codes and contains a
significant amount of asbestos. The
construction of the new District Office
building also created thousands of jobs
and pumped millions of dollars into the
local economy from 2004 through 2006.

Caltrans officially responded to Senator Anderson through Media Relations Manager Matt Rocco with the following statement:

"Caltrans agrees with Senator Anderson that state government must be as efficient as possible and shares the same goal of looking for ways to save taxpayer dollars. Caltrans is currently administering one of the largest construction programs in history with more than \$10 billion in projects underway. This is during a time when our staffing levels are the lowest they've been since 2004. In the past five years, Caltrans has delivered 1,388 of 1,391 highway improvement projects worth \$14.3 billion on schedule.

Working in partnership with local agencies, we are continually looking at ways to improve how we do business. In fact, over the last few years, we have significantly reduced our fleet, travel and vehicle-related spending, mobile phones, and level of management positions, saving taxpayers millions of dollars, all while maintaining more than 50,000 highway

lane-miles across the state. It should also be noted that Caltrans received national recognition for its emergency response to rebuild the MacArthur Maze interchange in 26 days following a catastrophic tanker explosion.

We extend an invitation to educate and clarify key points to Senator Anderson on the complexity of maintaining and operating one of the largest transportation networks in the world, as well as efficiency steps we have already taken over the last several years to ensure Caltrans is effectively using taxpayer dollars."

PECG Corporate also responded to Senator Anderson by issuing the following statement:

"Caltrans is and will continue to be responsible for ensuring the <u>safety</u> and integrity of the state highway system," said PECG President and State Engineer Matt Hanson. "Caltrans delivered 304 of 306 projects scheduled for bid during the 2009-2010 fiscal year. And over the past five year, Caltrans has delivered 99.8 percent of projects on or ahead of schedule."

By contrast, the Legislative Analyst's Office (LAO) reported last year that, local agencies obligated only 72 percent of their federal American Recovery and Reinvestment Act (ARRA) funds while Caltrans obligated 100% of its funds.

"According to the Department of Finance, it costs twice as much to outsource engineering work at Caltrans. Specifically, in the most recent budget, the Department of Finance concludes that a state engineer (including salary, benefits, overhead and equipment) costs the taxpayer \$113,000 a year while an outsourced private engineer costs an average of \$226,000 annually," said Hanson. "Local agencies outsource

almost all of their engineering services through no-bid contracts."

Section's General Meeting

On **February 17th**, the Section held its first



General Meeting of the year. Our guest speaker was Corporate President **Matt Hanson** who discussed the

latest bargaining issues. He said that we need to be open-minded about our expectations. The Governor and Legislature are under tremendous pressure to reduce the budget deficit. The recent survey showed that the majority of members prefer furlough days over additional pension contributions. It also showed that pay parity should be maintained. Over 100 members were in attendance.

Officers have received complaints about holding a General Meeting off site and after hours. Please keep in mind that this is done to accommodate our field staff and to allow more time for the presenters and for members to ask questions.

Caltrans Icon Retires with 52 Years of State Service

PECG Members Attend Rally in Support of Wisconsin State Employees.

On February 26th, various PECG



members attended the "We Are One"
Rally held by the San Diego Labor
Council. The main purpose was to show solidarity with Wisconsin state employees that are in danger of losing their collective bargaining rights. Over a thousand union members and supporters were in attendance during a rainy afternoon in front

of the San Diego County Administration Building in downtown. This was just one of hundreds of rallies held throughout the country. State Senator Juan Vargas and Assembly member **Toni Atkins** were just some of the politicians that attended. Union representatives were allowed to speak for about 5 minutes each. One of the most memorable was a representative of the San Diego Fire Department who spoke passionately to the crowd and made the point that "public safety" unions will stand strong with the rest of the government workers even though their unions have been largely shielded from the latest austerity measures.

PECG member John Williamson and his



son were in attendance. He said it was "good to see workers coming together and supporting each other. My son is 7 and he really loved it and got into it."

Edmund Kennedy also attended "Senator Juan Vargas gave a pretty good
rabble rousing speech as did the County
teacher of the year from last year."

Wisconsin state unions (safety exempted) had previously reached a tentative agreement to lower their salaries by 7%. Unions and Democrats were surprised when the Governor and Republican caucus tried to sneak in a provision within the budget bill that would eliminate most of

collective bargaining. **Indiana** and **Ohio** are also in the process of trying to eliminate most of collective bargaining.

Latest Update:

On **March 11th**, Wisconsin's Governor, Scott Walker, signed into law the bill that eliminates collective bargaining for public employees' health and benefits. The bill also limits the amount of payraises public employees may receive and removes the automatic collection of union dues.

Doug Dunaway Bridge Dedication

PECG has donated \$500 towards the naming of the New River Bridge on the State Route 78/Brawley Bypass in Imperial County. The Bridge will now be called the "Douglas B. Dunaway Memorial Bridge." A dedication ceremony will be held on March 4th.
